CAMPERSHIP FUND INFORMATION

BACKGROUND

The Spruce Lake Wilderness Camp **CAMPERSHIP FUND** was established to provide financial assistance to campers who would otherwise have difficulty paying camp tuition. It is our policy that the Wilderness Camp experience is available to every child regardless of ability to pay the full tuition. Campership funds come from these sources:

◆ **Al and Kass Detweiler Endowment**

Al, along with his wife Kass, was the founding director responsible for both the vision and beginnings of the Wilderness Camp Program. Together they served the ministry of Spruce Lake for 25 years. Al Detweiler passed in 2005 survived by Kass, 12 children, and 34 grandchildren.

◆ **Derek Todd Casey Endowment**

Derek lost his life in a car accident just after his camp experience in 1986. Because of his love for camp, this fund was established in his memory.

◆ **Ernest W. Alderfer Endowment**

In 1997, this endowment was designed in appreciation of Ernest, who served as a Spruce Lake board member for 30 years (1964-1994).

◆ **Annual Spruce Lake Golf Tournament**

This event raises funds for Wilderness Camp camperships and operations annually through individuals and organizations who give faithfully and generously.

◆ **Individual Gifts From Friends of Spruce Lake**

People, churches, and businesses interested in supporting Wilderness Camp give many gifts each year. Each year there is an annual appeal to help cover the campership needs for the upcoming summer.

FUND RESTRICTIONS

1. A Campership may only be applied one session per camper per summer.
2. The fund cannot cover the bus fee (\$10/\$15/\$20/\$30), the tuition deposit (\$50), or any other camp purchases such as a camp video or camp store deposit.
3. If there is church assistance we ask that the camper family be required for at least \$25 of the commitment.
4. A Single Scholarship may not exceed \$245 in a summer.

HOW TO APPLY

1. If the camper is involved in a church, ask your pastor if the church can provide assistance for camp tuition. If so, indicate the amount of tuition assistance the church will provide in #5 of the Campership Request section of the application. If no assistance is available, write "0".
2. Send in your application with a minimum of \$50 nonrefundable registration fee AND your registration form (if not already submitted). **Remember that Campership funds can only cover camp tuition charges, and are limited to a \$245.**
3. We will notify you, as soon as we can, regarding the status of your Campership. If you are not granted a scholarship for some reason, and you choose not to attend for this reason, the camp will refund your deposit.
